- All the charges are for one connection only (one Kitchen point and with one regulator and one gas meter, 15 meter of GI /Copper pipe free) In case GI/ Copper Pipeline exceeds 15 meters, charges for the extra pipe length, as applicable are payable.
- Equipment used in PNG connection like pipe, valve, meter, regulator etc. will be owned by the Company wherein customer has to protect them as a custodian. Any damages to such equipment, due to any reason whatsoever, shall be billed to the customer in next billing cycle. Accordingly, upon surrender of gas connection, if any, by the customer, the Company shall take back this equipment from the customer premises.
- If a customer wishes to move from Rental Plan to Regular Plan, the customer can do so by paying ₹ 6000/- as upfront Connection Security Deposit. All the rental amounts paid by the customer till then under the Rental Plan shall stand forfeited.
- If a customer wishes to move from EMI Plan to Regular Plan, the customer can do so by paying the balance Connection Security Deposit amount. For example, if the customer has already paid ₹ 2000/- under EMI Plan as Connection Security Deposit, then the customer is required to pay balance ₹ 4000/- upfront as Connection Security Deposit for moving to Regular Plan.
- If a customer wishes to move from Rental Plan to EMI Plan, the customer can do so by paying the Connection Security Deposit through EMI under the EMI Plan. All the rental amounts paid by the customer till then under the Rental Plan shall stand forfeited.
- Annual Maintenance Charges (AMC) of ₹ 150/- plus applicable GST will be charged after completion of 24 months and thereafter on a yearly basis under all schemes.

1. Conversion of nozzle for regular stove up to 2 burners is included in the connection cost for first time. Conversion of nozzle for different stove or more than 2 burners stove or for other than first time is not included in the connection cost and same is to be converted by customer at his/her own cost.
2. Gas connection will be provided based on technical suitability at customer premises.
3. Any alteration / modification in the Gas connection is to be done by the Company only based on technical feasibility at customer premises and will be charged additionally as per the Company policy.
4. Billing will start as soon as Gas is supplied to the customer.
5. Customer shall have to clear the outstanding and pay the applicable charges in advance at the time of applying for any of the gas connection related request as above.
6. A maximum of 3 extra points (Chargeable) can be provided over and above 1 main kitchen point to each customer, i.e., 1 point for kitchen (in the same kitchen, if any) and 2 for geyser connection.
7. Gas connection work shall start after booking (Registration) of Gas connection. If a customer wants permanent disconnection during the gas connection work, then it can be done after paying the charges of Gas pipeline (Underground/ over ground) and other equipment.
8. This tariff card shall form an integral part of the PNG Domestic registration / application form.
9. The above tariff card is subject to change from time to time and the same shall be intimated to customer through website / other medias.
